

Tualatin Valley Youth Football Contract Waiver

Contract Waiver & Rules and Regulations

I, as parent/guardian of said player/minor, hereby give permission for said minor to participate in any and all activities sponsored by said Association, and agree to release, indemnify, and to hold harmless the Association, Conference, including but not limited to its organizers, sponsors, supervisors, leaders, participants, officials, coaches and other agents or representatives including persons transporting said minor, from any and all claims arising out of injury to the above said minor except to the extent of, and in the amount of, insurance coverage held by the Association.

Rules and Regulations

I, as parent/guardian of said player/minor, and I, as said player/minor, understand that it is the responsibility of the parent/guardian, player/minor, team and Association to comply with any and all rules and regulations of said Association and the Tualatin Valley Youth Football League. Any noncompliance with rules and regulations shall be cause for disciplinary action being taken against said player/minor, parent/guardian, team or Association by the League.

Insurance Notice

The League has Group Accident Insurance Coverage for medical and hospital expenses, with a given deductible amount for each accident incurred. THE LEAGUE INSURANCE IS CONSIDERED SECONDARY COVERAGE, WHEN THERE IS ANY OTHER VALID AND COLLECTIVE COVERAGE PROVIDED BY PARENT'S INSURANCE. Maximum coverage is provided for any one accident with a given maximum dental coverage for sound, natural teeth. In executing the foregoing release, I/we, the undersigned hereby acknowledge and represent that: (A) I/We understand that any claim for medical service which arise out of injury must be reported to the team manager WITHIN TEN DAYS of the date of injury; (B) I/We have read the foregoing release and understand that any Registration Fee or other sums paid does not constitute a direct premium payment for insurance.

Eligibility and Medical Release

I understand that a Tualatin Valley Youth Football League medical release form to participate in tackle football, dated & signed after February 1st, must be presented at the time of official certification, and it is the responsibility of the parent/guardian and the player/minor to provide such proof of release. I understand that if proof of grade and/or physician's release is not provided prior to equipment distribution said player/minor is automatically ineligible for participation in any and all activities of the Association and/or League as a player and equipment will not be issued. I understand that the grade verification form needs to be submitted when I am fitted for equipment.

Fees and Refund Policy

Fees

I as parent/guardian of said minor, understand that most fees assessed by the Association and/or League are nonrefundable if the said minor participates in any activity of the Association after the Equipment Hand-Out.

Refund Policy

Any player who quits before July 1st is eligible for a full refund minus a \$100 processing and jersey fee. Any player quitting after July 1st will NOT be eligible for any refund. To initiate a refund please email us at info@tualatinyouthfootball.org

Equipment Policy

I, as parent/guardian of said minor, understand that equipment will not be issued nor will player participate until the aforementioned eligibility documents are provided to the Association Registrar. I do hereby assume full and complete responsibility for the proper care and maintenance of all equipment issued by the Association to said player/minor. I understand all equipment is to be used for Association and/or League activities only and that all equipment remains the legal property of the Association. I agree to reimburse the Association for any and all equipment that is not returned, lost or damaged or stolen for the value stated by the Association with payment due when equipment is returned at season's end. All equipment will be returned immediately upon the withdrawal of the said player/minor from the Association.
